Re: Canadian National Road Cycling Championships (CNRCC) Update #5

#### BACKGROUND:

A full CNRCC report was presented at Community Services Committee (CSC) meeting on March 7<sup>th</sup>, 2011. At that time, PR-16-11 outlined the various routes for the Cycling Championships. Of the 9 events, 6 were to be held in Burlington, including 5 races. In early April, Council was advised that the June 23<sup>rd</sup> race event would be relocated to Belfountain.

This update is one in a series of updates that Staff has been providing to Council and CSC on this event – and specifically requested at the last Council meeting. With the impending May 16<sup>th</sup> critical date for the Halton Regional Police Services (HRPS), this memo is intended to give Members of Council a brief event status update.

Through a series of bi-weekly meetings with the event organizer, City staff has developed and executed both agreements, confirmed the remaining 5 routes in Burlington, reviewed and revised traffic management plans, supported communication plans, and liaised with other municipalities and approval organizations.

A communication plan was submitted earlier in the process and the organizer went to the public on two separate occasions as well as hand-delivered letters to residents along affected routes.

Sponsorship and financial commitments remain two key items of concern. In March, financial issues involving the HRPS led to the setting of the hard date for funding commitments to the Region, which are to be fully secured.

#### **CURRENT STATUS:**

On May 5<sup>th</sup> a full routing meeting was chaired by Transportation Services, at which all in attendance were hand delivered two notices; which indicated that a further 2 events (June 30<sup>th</sup> and July1) would also be relocated to venues outside of Burlington and Halton Region. This was the City's first indication that either event is to be relocated. Copies of both letters delivered are attached to the end of this update. Additionally a meeting between the BHA, Tourism, City staff and the event organizer was held later in the day. The results of that

meeting are captured in a letter from the BHA to the event organizer indicating their position on the status of their support and subsequent funding, should the July 1<sup>st</sup> event not take place in downtown Burlington. A copy of that letter is also included at the end of this update.

Table 1 below is taken from report PR-16-11, showing the road races that were originally approved, and updated to reflect the changes in races as of the May 5<sup>th</sup> meeting.

For the remaining two routes, the traffic management plan (pedestrian and vehicular), emergency accesses, safe public access, and mitigation strategies were discussed. All parties had opportunities to discuss based on the proposed revised plans from SIDAN. Although there are still some outstanding access and routing concerns, including the 403 ramp closures, the routing committee continues to work towards finalizing the routes. An additional meeting is scheduled for next week to resolve remaining issues.

Per Burlington events protocols, additional updates to residents affected by the routes were to be delivered on a timely basis in March/April and again in June. However, due to the changes in venue and outstanding access and mitigation concerns, the event organizer preferred to defer the spring letter and produce a more comprehensive and accurate communication. Access and mitigation matters are being sorted through as part of the traffic management plans discussed above. Once the remaining two routes have been finalized, a letter to affected residents will be distributed by the event organizer; which will update access and mitigation opportunities.

The timing of this May meeting was critical to allow HRPS enough time and input to ensure all public safety measures are adequate for the events, and which would allow them ample time to confirm their costing measures. At this point HRPS is confident that public safety will not be put at risk with the implementation of the strategies that they have recommended for maintaining access. Their date for full payment of the remaining events remains unchanged

from the May 16<sup>th</sup> date, as previously agreed-to by Midweek Cycle. Additionally, the Costing Agreement between the parties remains unsigned.

At the May 5<sup>th</sup> meeting, additional information regarding sponsorship and financial strategies were also requested. No additional information has been received. At this point the event organizer's program strategy is based on revenues collected from the participants. To the extent that additional sources of funding are realized, additional complimentary aspects may be added.

As of May 5th, the following items remain outstanding:

- Finalization of traffic management plan for two remaining routes
- > Approval & final costing by Halton Regional Police of traffic management plan
- City of Hamilton approvals for traffic management plan
- MTO, GO Transit, and VIA approvals for Hwy 403 & Waterdown Road ramp closures
- Communications plan
- Confirmation of financial capacity

Staff will continue to work with the event organizers and event partners on the 'Aldershot' and 'Rattlesnake Point' routes with the hope of achieving completion of all requirements in a timely manner. In 2009 the 'Aldershot' race was successfully concluded. Both of these events are viable as stand-alone competitions.

In consideration of the foregoing developments, and the relocation of 60% of the races originally scheduled for Burlington; questions surrounding the status of City of Burlington funding and support are being considered. Specifically, is the support still warranted? Staff will be present at Committee for further discussion.

Dear Craig,

As of our meeting Thursday, May 5<sup>th</sup> 2011, we the Burlington Hotel Association (BHA) understands and appreciates the financial obstacles that have been hindering the progress of detailing all aspects of the 2011 Canadian National Road Cycling Championship. As such we are willing to accept the removal of the time trials on the 30th of June. 2011.

At the same time the Burlington Hotel Association strongly urges you and your board to reconsider your decision to also relocate the July 1st event. As you are aware, your "guarantee" (email- March 23, 2011. see below) of this event triggered a number of large undertakings on behalf of multiple organizations within the city to ensure this event had city-wide focus and that this City-wide event was a successful addition to not only the 2011 Canadian National Road Cycling Championships but also to our Canada Day Celebrations.

In consideration of the aforementioned and in conjunction with the concessions already agreed to, the further removal of the July 1st event will be interpreted as a failure to live up to the "formal notice" as outlined below as well as our agreement. This will cause the Burlington Hotel Association to re-examine all parts of our partnership up to and including financial contributions.

To ensure proper timelines (which we were not afforded today) and communication windows, I am again requesting "formal notice" of your decision by the Community Services Committee meeting scheduled for Wednesday May 11" 2011.

Please accept this e-mail as formal notice that the organizing committee has decided that the Canada Day I Burlington Criterium will occur on July 1 in Downtown Burlington as outlined previously.

Please appreciate that due to the question mark surrounding receiving permission to host the race in the Burlington's Downtown location and during the time period desired, the event organization team was /forced to search-out a back.-up venue.

While the traditional Canada Day Criterium sponsors wishes to host the event and the costs associated with hosting it in their venue are \$0 for police/security services, in the spirit of
